Current Status

- Signed the Franchise Disclosure Document with Kid Junction Franchise System.
- Hired All Kids Play, Inc to do the feasibility study. The results of the feasibility study are very promising.
- Hired a design group, a commercial real estate agent, a real estate attorney and a franchise attorney
- Secured financing (Commitment Letter) from a local community bank.
- Leased the space at 4090 Lafayette Center Dr, Suite E, Chantilly, VA 20151.
- Special Permit and Building Permits have been applied with Fairfax County. Special Permit hearing is scheduled for 02/13/2013.
- General Contractors bidding process complete and bids are currently being reviewed.
