## Dominion Cove Point LNG, LP Proposes Eastern Market Access Project

On November 15, 2016, Dominion Cove Point LNG, LP (DCP) filed with the Federal Energy Regulatory Commission (FERC), in Docket No. CP17-15-000, an Abbreviated Application for a Certificate of Public Convenience and Necessity, pursuant to section 7 of the Natural Gas Act, for authorization to construct, install, own, operate, and maintain certain facilities located in Charles County, Md., and Loudoun and Fairfax counties, Va., that comprise the Eastern Market Access Project. DCP seeks authorization for this project by September 2017. The details of this proposal are more fully set forth in the Application that is on file with the FERC and open to public inspection.

Specifically, DCP is seeking authorization of its "Eastern Market Access Project" (Project) which will enable DCP to provide 294,000 dekatherms per day of firm transportation service to two regional customers. The project would add compression and auxiliary facilities along Dominion's existing interstate natural gas transmission pipeline. Construction plans include a new compressor station in Charles County, Md. at an existing operating DCP facility property (which currently has a launcher/receiver, interconnection and maintenance building), installing two new taps on our existing pipelines in Charles County, Md., installing a new electric compressor unit at our existing Loudoun Compressor Station in Loudoun County, Va., and re-wheeling a compressor at our existing Pleasant Valley Compressor Station in Fairfax County, Va. No new pipeline right of way would be required for this project.
