NOTE: The above is a generalized summary for comparison only and does not include many of the details, definitions and exceptions in the code provisions.

Typical Problems Cited

- Major focus on commercial vehicles that don't fit code definition:

Existing Code Section 82-5-7. Parking commercial vehicles in residential districts.

Commercial vehicle includes: (i) any solid waste collection vehicle, tractor truck or tractor truck/semitrailer or tractor truck/trailer combination, dump truck, concrete mixer truck, towing and recovery vehicle with a registered gross weight of 12,000 pounds or more, and any heavy construction equipment, whether located on the highway or on a truck, trailer, or semitrailer; (ii) any trailer, semitrailer, or other vehicle in which food or beverages are stored or sold; (iii) any trailer or semitrailer used for transporting landscaping or lawn-care equipment whether or not such trailer or semitrailer is attached to another vehicle; and (iv) any vehicle licensed by the Commonwealth for use as a common or contract carrier or as a limousine.

Proposed Code Changes - 1

New restrictions in Sec. 82-5-7, Parking Commercial Vehicles in Residential Districts:

- Require taxis/limos to be registered in Virginia
- Restrictions for size, weight, type of vehicle including vehicles:
 - > more than 20' long (HB 1694)
 - > more than 8' high including appurtenances
 - > more than 102" wide
 - > GVW of 12,000 or more pounds
 - > carrying commercial freight in plain view (HB 1694)
 - > any trailer or semitrailer except camping trailer, boat trailer, or single axle
 - > 3 or more axles
- Specific language on service roads adjacent to residential areas



Trailer or semitrailer except those designed to be used as a camper trailer or boat trailer or a single axle utility trailer, regardless of whether such trailer or semitrailer is attached to another vehicle;

Other Proposed Code Changes - 2

Other new requirements / modifications:

- Require license tags on both front and rear of vehicle (Sec. 82-5-26)
- Require current safety inspection sticker (Sec. 82-5-26.1)
- Other minor and "clean-up" changes

Summary

- Major code changes will affect a substantial number of residents
- Will not solve all problems but is expected to substantially reduce parking complaints
- May consider grace period and outreach program to allow time for transition and implementation
- Complete re-write of Chapter 82 planned
